Privacy Notice - Santa Special Bookings

It is necessary for Leicester Society of Model Engineers (LSME) Ltd to collect and use certain personal information. This privacy notice tells you what to expect us to do with the personal information collected on your Santa Special booking form.

What information LSME Ltd collects and uses, and why

LSME Ltd collects the contact details (name, address, and telephone number) of customers submitting a Santa Special booking form to manage your booking.

LSME Ltd also collects the age and gender of any children for which tickets are requested to allow Santa to select an appropriate gift.

The lawful basis for collecting and using personal information to process and manage membership is "contract" (the booking).

Where LSME Ltd gets personal information from

LSME Ltd collects personal information directly from customers using the Santa Special booking form.

How long LSME Ltd keep personal information

Personal information will only be kept and used by LSME Ltd for as long as it is needed.

Typically, customer contact details (name, address, and telephone number) and the age and gender of any children will be retained until the Santa Special event has taken place.

Data protection rights

Under data protection law, people for which LSME Ltd holds personal information have:

- right of access the right to ask for copies of their personal information;
- right to rectification the right to ask LSME Ltd to rectify personal information they think is inaccurate and the right to ask LSME Ltd to complete information they think is incomplete;
- right to erasure the right to ask LSME Ltd to erase their personal information in certain circumstances;
- right to restriction of processing the right to ask LSME Ltd to restrict the processing of their personal information in certain circumstances;
- right to object to processing the right to object to the processing of their personal information in certain circumstances;
